Sub: Passing of resolutions through Postal Ballot.

Pursuant to the resolution passed by the Board of Directors of M/s. Heritage Foods Limited (Herein after called HFL) on 10th August 2017, we have been appointed as scrutinizer to receive process and scrutinize the postal ballot papers (both Physical & Remote e-Voting) in respect of the Ordinary resolutions as circulated in the postal ballot notice dated 10th August 2017.

The Company had made arrangements with the system provider, Karvy Computershare Private Limited, Hyderabad to provide platform for recording votes of shareholders electronically through Remote e-voting. We report that the postal ballot notice dated 10th August 2017, under section 110 of the Companies Act, 2013 read with the relevant rules dispatched to shareholders in physical form by Courier along with self-addressed prepaid business reply envelope on 24th August 2017 for the following resolutions.

In addition to the above, postal ballot notices were also sent on 24th August 2017, via electronic mode by RTA to all shareholders at their e-mail addresses registered with the Depository participants as per the data downloaded from the CDSL and NSDL as on 18th August 2017 (cut off date).

we report that, we have received the postal ballot forms from the shareholders during the period starting from 24th August 2017 to 23rd September 2017 up to 5:00 PM. All the postal ballot forms together with all votes cast by Remote e-voting through Karvy Computershare Private Limited received up to 23rd September 2017 being the last date fixed by the Company for receipt of the ballot forms/e-voting were considered for our scrutiny.

On scrutiny, we report that 92 shareholders exercised their vote through e-voting and 38 shareholders exercised their votes through postal ballot forms in physical mode in Resolution 1 and 2.
